- Section 7 trail opening was discussed. It was voted to open but then concern was that snowmobilers would run through any caution tape up where sections are closed. - Diane Stormoen went over prices for the brat fry. Everyone said to make increases where she saw fit.

**Elections:** President, Secretary, Trustee
